**Recommendations for the 2018 Colvin Prize**

Dear Colleague:

The **Colvin Prize for Outstanding Achievement in Mood Disorders Research** is an award of \$50,000 given by the **Brain & Behavior Research Foundation** (formerly NARSAD), to an outstanding scientist carrying out work on the causes, pathophysiology, treatment, or prevention of bipolar illness. The scientist to be recognized is one who gives particular promise for advancing our understanding of affective illness or its basic brain mechanisms that will lead to new treatment approaches.

Please keep in mind that contributions may be in either clinical research or relevant basic science. If your own work qualifies, please also call it to our attention.

The submission of this information does not constitute a nomination of an individual, but will enable the panel to establish a list of eligible scientists for further consideration and deliberation.
