
HOW TO APPLY:

1. Prepare in advance the following documentation: CVs of the members of your team.
2. Go to the [EIT Health platform](#):
 - Create a user account in order to submit an application in the 'First Login' section.
 - **Select CRAASH Barcelona as the 1st option and year 2020.**
 - Complete the common questions for all the EIT Health Bootcamps (from 2 to 3). Please find below the full application form (step-by-step guide).
 - Answer the specific questions for CRAASH Barcelona Bootcamp (section 4).
 - Complete the rest of the common questions for all the EIT Health Bootcamps (from 6 to 7).
 - Check all your answers in the 'Summary' and click on 'Validate and send'. You can download your application.
 - You will receive a confirmation e-mail once the application is sent.
3. This process might take you an hour, so check the questions first in order to prepare your responses.
4. You do not need to save your answers. The auto-save mode is active.
5. Complete the application process **before March 16, 2020.**




