## Travelling awards, research grants, conference and lecture awards

- 1. Can awarded funds pay for salary expenses?**
  - The Thomas Davies Research Grant funds can cover research assistant salaries, but not primary researcher salary expenses. The Margaret Middleton Fund and Max Day Fellowship Awards are not able to cover any salary expenses, for either primary researchers or research assistants.
- 2. Can I apply for more than one research award?**
  - Yes – however, you can only receive one research award per calendar year. If you are ranked highly for multiple research awards, the assessment committee Chairs will decide which award is most appropriate for the project and applicant.
- 3. Can I receive the same research award for a different project in subsequent years?**
  - No – once you have received a research award, you are not eligible to receive the same award for 3 calendar years.
- 4. Can I use the funds to attend a conference?**
  - The Margaret Middleton Fund does not support conference expenses.
  - The Max Day Fellowship funds can be used to cover the cost of travel to undertake research or attend relevant conferences/workshops.
  - Thomas Davies Research Fund can support conference expenses IF it can be demonstrated that it is relevant for the project, however, this is not the primary objective of the award.
- 5. Can I use the funds to cover overhead expenses?**
  - No – each award notes the specific exclusions for use of funding; however, no award allows funds to be used towards bench fees, managerial, visa, insurance or infrastructure costs.
- 6. Can I request feedback on my application assessment?**
  - No – applications are assessed based on the competitiveness of the proposal by a committee of scientists with diverse expertise. The Academy is not able to enter into discussion or correspondence regarding the reasons why an application is successful or not.

## Honoric Awards – Early-career, mid-career and career medals

- 1. Can I nominate myself?**
  - No – you must be nominated by someone else. Self-nominations are not accepted.
- 2. Can I submit a nomination on behalf of someone else?**
  - Yes – you can submit a nomination on behalf of someone else if you are not the nominator. An example would be a university grants office or personal/executive assistant completing the online nomination form on behalf of a nominator. Once the form is submitted, the nominator will be sent an email confirming the nomination has been completed. If a nominee submits a nomination for themselves on behalf of a nominator it will not be considered a self-nomination.

### 3. Residency requirements

- Winners of all awards except the Haddon Forrester King Medal should be mainly resident and/or have a substantive position in Australia at the time of the nomination deadline. Unless explicitly stated in the awarding conditions, the research being put forward for the award should have been undertaken mainly in Australia. Some awards have more specific conditions that the relevant selection committee must apply and nominators are advised to read the conditions associated with each award very carefully.

### 4. Honorific Career Eligibility (more specific details found in the Honorific Awards nominator guidelines)

- Career Eligibility is calculated by calendar year.
- For example for the 2021 Honorific award round early career exemption calculations should be calculated for the period 1 January 2010 to 1 January 2020. 2021 Honorific award Post PhD\* Eligibility guidelines.
- By the same token for the 2021 award round Early Career awardees are required to have their PhD's\* conferred on or after 1/1/2010\*\* and Mid-Career awardees between 1/1/2005 and 1/1/2012\*\*.
- \* or equivalent first higher degree eg., D.Phil., D.Psych., D.Sc.
- \*\*Please note that the Awards Committee may consider nominees with Post PhD dates outside of these ranges if a career exemption requests is being submitted with the nomination, further guidelines on career exemption requests can be found in the nomination guidelines.

### 5. Academy fellowship requirements in award nominations

- Fellows and non-Fellows of the Academy can provide nominations for either Fellows or non-Fellows for all awards except the Macfarlane Burnet Medal and Lecture, the Matthew Flinders Medal and Lecture and the Ruby Payne-Scott Medal and Lecture. The Macfarlane Burnet Medal and Lecture, the Matthew Flinders Medal and Lecture and the Ruby Payne Scott Medal and Lecture can only be nominated by Fellows of the Academy and can be awarded to either Fellows or non-Fellows.

### 6. Women only awards

- The Dorothy Hill, Nancy Millis and Ruby Payne-Scott Medals are for women only.
